

Kent County Parks & Recreation Student Advisory Board Member

Kent County Department of Parks & Recreation is seeking student representation as a full member of its Advisory Board. The mission of Kent County Parks & Recreation is to create balanced opportunities for our patrons to play, learn, and grow through our programs and parks.

The one year (July to June) appointment to the Parks & Recreation Advisory Board requires a high school student member to meet on the second Monday of February, and the third Monday of May, August, and November. Additional meetings are held when necessary to conduct time sensitive business. Meetings are held at 6 pm at the Kent County Community Center.

A student representative for the Advisory Board must be a Kent County student, high school age, and must provide his or her own transportation to and from the regularly scheduled meetings. The selected student board member must possess and maintain a cumulative GPA of 2.0 or better and demonstrate strong values and character. Involvement in extra curricular activities such as team/individual sports, drama, student government, arts and music or other civic minded activities are also favorable.

Candidates must submit a resume (with references and contact information) and a cover letter including why he or she would like to serve as a member of the Parks & Recreation Advisory Board generally by June 1, however interest forms and supporting information is accepted any time of the year for future consideration when an opening may arise. Applications will be reviewed by department and current Advisory Board members for consideration. Recommendations will be forwarded to the Kent County Commissioners for final approval and appointment to begin at the July meeting (or later if recommended for approval later in the year).
