FACILITIES

- BATHHOUSE HOURS 10:00AM-6:00PM PARK IN DESIGNATED PARKING AREAS
- WEEKENDS ONLY MAY MID JUNE
- DAILY MID JUNE LABOR DAY
- WEEKENDS ONLY LABOR DAY END OF SEPTEMBER
- SWIM IN DESIGNATED SWIMMING AREAS ONLY
- PARKING LOT AND PUBLIC LANDING CLOSED 10:00 PM UNTIL 5:00 AM.
- PARK IN DESIGNATED PARKING AREAS ONLY. VIOLATORS WILL BE TOWED AT VEHICLE OWNER'S EXPENSE
- BEACH AND PAVILION CLOSED DUSK TO DAWN
- NO JUMPING OR SWIMMING FROM JETTY OR PIER

RULES & REGULATIONS

- NO ALCOHOLIC BEVERAGES
 PERMITTED WITHOUT A PERMIT
- NO GLASS CONTAINERS PERMITTED
- NO APPARATUS PERMITTED TO BE HUNG FROM TREES
- NO PETS PERMITTED ON BEACH (SAND) DURING PUBLIC BEACH PERMIT SEASON (MAY-SEPTEMBER)
- ALL PETS MUST BE LEASHED
- GAS, PROPANE, AND OR TABLE TOP GRILLS ARE NOT PERMITTED
- POP UP TENTS ARE NOT PERMITTED IN GRASS AREA

- MUSIC CONTENT AND VOLUME
 MUST NOT CAUSE UNDUE
 DISTURBANCE TO OTHERS
- SKATEBOARDS, ROLLER
 SKATES/BLADES, AND BICYCLES
 ARE NOT PERMITTED ON
 BOARDWALK AND IN PICNIC
 PAVILION
- POP UP TENTS PERMITTED ON BEACH (SAND) ONLY AND MUST BE AT LEAST TEN (10) FEET BEHIND LIFEGUARD STAND WHEN LIFEGUARDS ARE ON DUTY

Violators who do not comply with regulations will be asked to leave the premises. Failure to leave premises after so directed shall be considered criminal trespassing. Kent County Government reserves the right to implement additional regulations as deemed necessary.
