## Student Advisory Board Member Criteria and Expectations

Kent County's Department of Parks & Recreation is seeking students to serve as full voting members of its Advisory Board. The mission of Kent County Parks & Recreation is to create balanced opportunities for our patrons to play, learn, and grow through our parks and programs.

The one year appointment (July 1 to June 30) to the Parks & Recreation Advisory Board requires a high school age student member to meet four times per year (generally the 3<sup>rd</sup> Monday of August, November, and May, as well as, the 2<sup>nd</sup> Monday in February) at 6 pm at the Kent County Community Center. Additional meetings may be scheduled if needed. The student member is expected to take a lead role in assisting with coordination of youth events. A student member appointment may be extended for an additional one year term at the discretion of the Board of County Commissioners of Kent County.

A student representative for the Advisory Board must be a Kent County high school age student and must provide his or her own transportation to and from meetings. A student board member must possess and maintain a cumulative GPA of 2.0 or better and demonstrate strong values and character. Involvement in extra curricular activities such as team/individual sports, drama, student government, arts and music or other civic minded activities are also favorable, but not required.

Candidates must submit a Kent County Boards and Committees Interest Form, resume (with references and contact information) and cover letter including why he or she would like to serve as a member of the Parks & Recreation Advisory Board, preferably by June 15th for the current year to:
